Public Hearing

BOA-1-2024 Application from Halie Cantrell requesting a variance of Section 153.050 of the Lincolnton Unified Development Ordinance in regard to lots abutting a dedicated street. The variance would allow the lot (Parcel ID 59121) to be served by a 20-foot easement to construct a single-family home. The subject property is located approximately 203 feet northeast of Henry Rhodes Road located behind property at 773 Henry Rhodes Road (Parcel ID 21428).

Ashley Jones presented the staff report in the agenda packet to the Board regarding BOA-1-2024.

Staff recommended that the driveway be expanded to 12 ft in width and made of gravel or asphalt.
